### **Programme Outline**

This programme is expected to take 2.5 to 3 years to complete.

This flexible programme will allow training to take place within a variety of drilling environments. The training programme includes a mix of practical training and assessment, undertaken in the workplace, and theory learning and assessment, allowing you to complete theory elements of the programme at your own pace.
